

ORDINANCE NO. 7796

A ZONING ORDINANCE IN RE CASE #47JUN14
City of Belleville

THE CITY OF BELLEVILLE, ST. CLAIR COUNTY, ILLINOIS (THE "CITY"), IS A DULY ORGANIZED AND EXISTING MUNICIPALITY CREATED UNDER THE PROVISIONS OF THE LAWS OF THE STATE OF ILLINOIS.

THE CITY OF BELLEVILLE IS NOW OPERATING UNDER THE PROVISIONS OF THE ILLINOIS MUNICIPAL CODE, AS SUPPLEMENTED AND AMENDED AND AS A HOME RULE MUNICIPALITY PURSUANT TO ARTICLE VII OF THE ILLINOIS CONSTITUTION OF 1970; AND IN THE EXERCISE OF ITS HOME RULE POWERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEVILLE, ILLINOIS:

Whereas, an application has been filed requesting a Sign Installation Permit for the Area of Special Control in order to place one freestanding sign totaling 16 square feet, two flush-mounted wall sign totaling approximately 10 square feet each, and one awning sign totaling approximately 10 square feet in area, for a total of 46 square feet of signage at 407 East Lincoln Street, in a C-2 Heavy Commercial District. (Applicable portion of the Sign Code: 53-4-6).

Whereas, a public hearing has been held before the City's Zoning Board of Appeals which has issued its advisory report.

NOW, THEREFORE, be it ordained by the City Council of the City of Belleville, Illinois as follows:

Section 1. That the application requesting a Sign Installation Permit for the Area of Special Control in order to place one freestanding sign totaling 16 square feet, two flush-mounted wall sign totaling approximately 10 square feet each, and one awning sign totaling approximately 10 square feet in area, for a total of 46 square feet of signage at 407 East Lincoln Street, in a C-2 Heavy Commercial District is hereby granted. (Applicable portion of the Sign Code: 53-4-6).

Section 2. That conflicting ordinances or pertinent portions thereof in force at the time of this ordinance takes effect are hereby repealed.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication, all as provided by law.
