



City of Belleville Sidewalk Replacement Grant Program

The City of Belleville is pleased to offer this Sidewalk Replacement Grant Program for low-income residents. Program criteria and income limits are listed below.

Program Criteria/Requirements

- Residence and sidewalk(s) must be within the corporate limits of Belleville.
- Only sidewalks within the City of Belleville Right-Of-Way are eligible for replacement grants. Any sidewalk(s) replaced/repared on private property will be the responsibility of the homeowner.
- Only owner-occupied, single-family residential properties are eligible.
- Applicants must meet income limits listed below.
- Applicants must also provide:
 - Occupancy Permit and proof of ownership of residence (e.g. copy of Warranty Deed, Quit Claim Deed).
 - Proof of current paid property tax bill.
 - Proof of homeowners insurance.
 - Documentation of total household income (e.g. two most recent pay stubs).
 - Current utility bill.
- Applicants must be current on all payments to the City of Belleville (e.g. sewer/trash bills) or have an approved payment plan in place with the City Treasurer’s office to be eligible for this program.
- A completed, signed and dated application must be submitted to the City of Belleville for consideration. Incomplete applications will be returned to the applicant for completion.
- Determination of sidewalk condition/eligibility and priority of sidewalks to be replaced will be made by the City of Belleville Engineering Department.
