 - Repetitive public comments should be avoided, to the extent practical, through adoption of prior public comments (ex. agreeing with a prior speaker).
 - The following conduct is prohibited during public participation:
 - acting or appearing in a lewd or disgraceful manner;
 - using disparaging, obscene or insulting language;
 - personal attacks impugning character and/or integrity;
 - intimidation;
 - disorderly conduct as defined in Section 30-1-2 of this Revised Code of Ordinances;
 - Any speaker who engages in such prohibited conduct during public participation shall be called to order by the chair or ruling by the chair if a point of order is made by a sitting Alderman.
