One chimney will be rebuilt at the front left of the museum and three new replacement chimneys will be built: one at the front right, one at the right rear and the other one at the left rear of gable roof portion on the house. All four will be five feet high each, capped, two widths of brick, tan or brown colored. The roof will be a 20 inch wide metal panel with standing seams on the north and south sides of the gable roof. If the medal roof is not feasible, then a new 3 tab architectural shingle roof will be used.

Mr. LeChien said that this letter would be on city letterhead because it will show the home owners and realtors that the commission is an arm of the city government. That the commission is not like a historical society or anything else. This was the original idea for the letter showing city backing of the commission and then for future newsletters, go back to the regular newsletter templet.

Miscellaneous

Mr. LeChien stated that the first Saturday in June is Museum Day and that there is a community group that is promoting a Bike and Walk activity on this day. This will be between the Museum of Labor and Industry and the other museums with the Old Belleville Historic District.
