PUBLIC PARTICIPATION (2-3 MINUTES PER PERSON)

- (a) Members of the public may address the City Council in accordance with Section 2.06(g) of the Illinois Open Meetings Act (5 ILCS 120/2.06(g));
- (b) Public comments are limited to three (3) minutes per speaker;
- (c) The subject of public comments shall be reasonably related to matters(s) identified on the meeting agenda and/or other city business;
- (d) Repetitive public comments should be avoided, to the extent practical, through adoption of prior public comment (e.g. agreeing with prior speaker);
- (e) The following conduct is prohibited during public participation:
 - Acting or appearing in a lewd or disgraceful manner;
 - Using disparaging, obscene or insulting language;
 - Personal attacks impugning character and/or integrity;
 - Intimidation;
 - Disorderly conduct as defined in Section 130.02 of this revised code of ordinances.
- (f) Any speaker who engages in such prohibited conduct during public participation shall be called to order by the chair or ruling by the chair if a point of order is made by a sitting alderman.

**PUBLIC NOTICE OF PROPOSED PROPERTY TAX
INCREASE FOR THE CITY OF BELLEVILLE**

- I. A public hearing to approve a proposed property tax levy increase for the City of Belleville for 2017 will be held on December 11, 2017 at 6:30 P.M. in the City Council Chambers at Belleville City Hall.

Any person desiring to appear at the public hearing and present testimony to the taxing district may attend the meeting at 101 S. Illinois St. Belleville, IL 62220.

- II. The corporate and special purpose property taxes extended or abated for 2016 were \$10,086,011.

The proposed corporate and special purpose property taxes to be levied for 2017 are \$11,294,375. This represents an 11.98% increase over the prior year.

- III. The total property taxes extended or abated for 2016 were \$10,086,011. The estimated total property taxes to be levied for 2017 are \$11,294,375. This represents an 11.98% increase over the previous year.
