Dave brings the experience, leadership, communication skills, and positive character needed for this position. David L. Zahn will be paid the same as budgeted for Arthur Jacobs' position for the 2020/2021 fiscal year. The amount budgeted for the position is \$52.1622 per hour, which equates to \$108,497.38 per year.

He read today in the Belleville News-Democrat that Shalondria Simpson from Texas is opening a cultivation facility on Route 15. He was curious on how many questions will be brought forward and if it will be public.

*Mayor Eckert advised Council will ask questions/discussion. This has been vetted with the Zoning Board of Appeals.*

**Shalondria Simpson**

She stated she is a pharmacist and has been since 2008. She has a Doctorate Degree in Pharmacy from Texas Southern University. She owns her own business. She is wanting to bring businesses, positiveness with no negativity to the City of Belleville. She understands there are people against cannabis and medical marijuana; however, they are trying to make it as City friendly as possible.

She owns her own pharmacy with government contracts with the Department of Labor. She does bedside delivery. She also has her own CBD product line. She has experience in medical marijuana industry, and they are trying to partner with the City. She has partnered with cannabis consultants who have years of experience which includes buildouts and design.

The construction has already laid out a plan which will allow to hire local construction workers as well as local people for employment. Her partner Michael Hume grew up in E. St. Louis, he has been in the area for approximately four (4) years and is familiar with the area and community involvement.

(Applicable sections of the Zoning Code: 162.308, 162.515) Ward 8 **Zoning Board recommended Approval, in the name of the Applicant only, by a majority vote of 4 -2.**

*Discussion...*

Alderman Wigginton asked how long is the process to approve the application and if the two co-owners will be moving to the area and be hands on owners?

Alderman Wigginton advised this will be a warehouse that will be hard to see from Route 15, will be well lit, 24-hour security.

Alderman Wigginton requested the only thing on the building is the address, no name.

Alderman Wigginton stated the Ordinance and Legal Committee designated eight (8) areas for this type of business. This is one of the areas. The City will receive licensing fees, 3% of the gross.

Shalondria Simpson advised that due to COVID-19 the application process has been pushed back and she hopes to know if they won the application at the end of August. Four owners of the team will be located here permanently and will be hands on in the business.

There will not be a neon sign, they will not be selling to the public. She will need to refer to the regulations regarding the signage.

Alderman Wigginton advised the State of Illinois vets this type of business not the City of Belleville or St. Clair County. If the State of Illinois does not approve where does this go; Mayor Eckert asked if the closing on the property is contingent on the approval; Shalondria Simpson stated yes.

Alderman Ovian asked if they are licensed to sell nationwide or just the State of Illinois; Shalondria Simpson advised just within the State of Illinois.

Alderman Ovian asked who this will be sold to; Shalondria Simpson advised there is a shortage of cannabis in the State so she will be selling to surrounding dispensaries.

Alderman Elmore asked Director of Residential and Commercial Development Services, Annissa McCaskill to explain the questions/votes of the Zoning Board of Appeals; Director of Residential and Commercial Development Services, Annissa McCaskill, advised there was no rationale to the two no votes; there were questions regarding the entrance to the City. Dr. Simpson is going for a warehouse instead of a greenhouse. There was a neighbor that spoke at the July 6, 2020 Council meeting and his attorney was on the phone.

Alderman Randle asked from an economic standpoint what is the economic benefit to the City...Alderman Wigginton stated the City will receive 3% from the gross. What mechanism provides for this; City Attorney Hoerner stated the 3% comes from retail sales at a dispensary, not from wholesale. With wholesale, 8% goes to local government, the City gets a per capita portion of the State Cannabis Cultivation which is 7%. This is dedicated to crime prevention training, etc.

Director of Residential and Commercial Development Services, Annissa McCaskill, advised this requires an annual business license which costs \$5,000 annually, for each facility.

## CITY ATTORNEY REPORT

Pursuant to Section 31.128 of the Revised Code of Ordinances, I write to provide a quarterly report on pending legal matters.

- A. Ordinance Violation Cases.** The City currently has approximately 232 ordinance violation cases pending.
- B. Demolition/Foreclosure/Housing Cases.** The City currently has 35 cases pending involving demolition or foreclosure proceedings, or other housing code/building code violations. The addresses of the subject properties are as follows:

C. **Other Civil Cases.** The City currently has pending the following other civil cases in which I am representing the City:

1. *Orchards Homeowners Association of Belleville v. City of Belleville.* On April 22, 2015, Plaintiff filed a Complaint against the City alleging a breach-of-contract theory related to an IDNR Permit for the construction of improvements to an unnamed tributary of loop creek. On October 29, 2015, after the Court denied the City's Motion to Dismiss, I filed an Answer and Affirmative Defenses. The parties have settled this matter in conjunction with an administrative enforcement action filed by the Illinois Department of Natural Resources. The IDNR administrative action has been dismissed with prejudice, and the civil action was likewise dismissed with prejudice by the St. Clair County Circuit Court. This matter is now concluded.
2. *City of Belleville v. JRG Holdings - Belleville, L.L.C.* On November 14, 2018, the City filed a Complaint for Declaratory Judgment concerning Defendant's Property at 104 North High, Belleville, Illinois (Brede Towers Apartments). Specifically, the City is seeking:
  - a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendant has willfully allowed the Property to become injurious to the health and dangerous to the lives of the occupants thereof and of the public in violation of Section 92.02 of the City's Revised Code of Ordinances, as well as permitting the existence of a dangerous building in the City and further permitting same to be occupied while it is or remains in a dangerous condition in violation of Section 93.041 of the City's Revised Code of Ordinances, thereby empowering Plaintiff to immediately revoke all current occupancy permits on the Property pursuant to Section 154.22 of the City's Revised Code of Ordinances and cause the immediate vacation of the residents of such Property;

- a permanent injunction requiring Defendants to immediately put the Property in good safe and sanitary condition in compliance with applicable codes and ordinances relating to sanitation, health, and housing, including but not limited to correcting the aforementioned violations/deficiencies related to the City electrical, mechanical, plumbing and fires safety codes, at Defendant's sole cost and expense.
3. *Belleville Professional Firefighters, IAFF Local 53 v. City of Belleville.* On August 7, 2019, Belleville Professional Firefighters, IAFF Local 53 filed a Complaint for declaratory judgment seeking to invalidate the City's ordinance providing procedures related to the Illinois Public Safety Employee Benefits Act (Sections 33.101 through 33.106 of the City's Revised Code of Ordinances. On City's behalf, I filed a Motion to Dismiss which remains pending.
  4. *Michael Hagberg v. City of Belleville.* On January 30, 2020, Plaintiff filed a so-called "Motion for Writ of Mandamus", purportedly seeking *mandamus* relief concerning various expenditures from tax increment financing districts within the City of Belleville over several years. On City's behalf, I filed a Motion to Dismiss which remains pending.

There are other lawsuits being handled through the City's insurance company.

- D. Other Miscellaneous Cases.** In addition to the above cases, there are a number of cases where the City is named as a Defendant in mortgage foreclosure lawsuits. The City is named as a Defendant because of municipal liens. These liens are typically extinguished in the foreclosure action. It is doubtful if the City will collect any of the amounts liened from these cases. There are also a number of cases where the City has filed proof of claims in Bankruptcy Court. These proof of claims are normally for sewer or trash charges and, in most cases, the City is unable to collect on any of these.

The costs of continued vehicle maintenance for the existing vehicles slated for replacement, bid preparation and labor costs are a financial liability to the City and significantly delay the delivery of ordered vehicles.

I recommend the six police interceptor vehicles be purchased directly from the approved State bid contractor (Morrow Brother's Ford) for the 2019/2020 fiscal year.

Sir,

Per your direction I have compiled information regarding the bid process for the purchase of new squad cars in comparison with ordering directly from the dealership awarded the state bid. My findings are as follows:

For the 2018-2019 fiscal year the city awarded Tri-Ford the bid for six Ford SUVs at the price of \$192,552.00. It was later discovered that Tri-Ford was unable to provide these cars due to a shortage from Ford.

The State Bid contract, Morrow Brother's Ford, was able to procure five Ford SUVs for us with most of the options we wanted for the price of \$163,975.00.

I removed one vehicle from the Tri-Ford price to reflect a fair comparison to the state bid, and added the amount of money required for parts, labor, and general upkeep for the existing units slated for replacement, as well as the time in labor required for preparing documentation for the bid process. The bid process took place in July and cars were finally ordered in October. During that time the city spent at or near \$8,697.00 in upkeep of the four existing units slated for replacement and bid preparation.

This total, added to the initial bid price comes to \$169,227.00. The price from the state bid came in at \$163,975.00.

Although the initial awarded bid came in at \$3,445.00 cheaper than the state bid, the city spent \$8,697.00 and thus a grand total of \$5,252.00 more was spent by using the bidding process.
