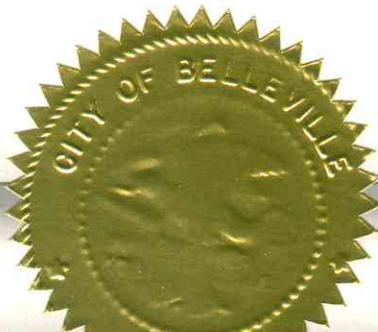

Alderman Wigginton made a motion seconded by Alderwoman Stiehl to approve the following cases:

39-SEP-20 – Sylvester Radley: A request for a Use Variance to re-establish two dwelling units on the second floor at 9700 West Main Street (parcel #02-35.0-210-040) located in a “C-2” Heavy Commercial District. (Applicable section of the Zoning Code: 162.570) Ward 8 *Zoning Board unanimously recommended Approval.*

40-SEP-20 – Sylvester Radley: A request for a Special Use Permit to establish a convenience store, with a print shop, and food preparation for carry-out and delivery, at 9700 West Main Street (parcel #02-35.0-210-040) located in a “C-2” Heavy Commercial District. (Applicable section of the Zoning Code: 162.248, 162.515) Ward 8 *Zoning Board recommended Denial by a vote of (5-2).* Conditions: Said use be limited to delivery of goods and services, there shall be no walk-up store sales.

Discussion...

Director of Residential and Commercial Development Services, Annissa McCaskill, advised there has been discussion regarding parking, apartment over a restaurant use. The Radley’s are aware if the apartment is in use it will be subject to crime free housing, meet all building and fire code requirements. There are currently 25 parking spaces on the lot and there will be a maximum of five (5) employees on the first level. Parking for the apartment is 1.5 spaces per unit and with two units will result in two (2) parking spaces and seventeen (17) spaces for the food and carry-out. In addition, the Radley’s are not targeting the type of uses that are across the street from them. They are not selling gas, tobacco or liquor. They would like to have a delivery base service that if someone calls in for delivery of food or any additional items.

Director of Residential and Commercial Development Services, Annissa McCaskill, stated regarding the convenience store use Alderman Wigginton had conditions to be added to the ordinance; Alderman Wigginton stated the following conditions should be added in the Ordinance. (1) delivery service...not a convenience store.

Director of Residential and Commercial Development Services, Annissa McCaskill, advised Assistant City Attorney Flynn provided the following language: establishment of a convenience store at 9700 West Main with the stipulation that said use be delivery of goods and services and there will be no walk-up store sales.

Alderman Hazel asked if the words “carry out” will be stricken from the Ordinance. Director of Residential and Commercial Development Services, Annissa McCaskill, advised they can have carry out for food since they will have a food business; however, the issue was the convenience store and having walk up service for the convenience store and the Radley’s agreed the majority of their business and what they are focusing on would be delivery of items that people would be typically purchasing from the convenience store.

Alderwoman Duco asked if they are selling liquor; Mayor Eckert advised no liquor will be sold.

Alderman Elmore made a motion seconded by Alderman Randle to deny a contract with Water Odyssey for design and build services for municipal splashpad at Bicentennial Park with build contract at later date.

Discussion...

Alderman Kinsella

Alderman Kinsella stated the City has a \$300,000 grant that is going pay for the majority and the rest will be paid for by Parks and Recreation. Parks and Recreation has been accumulating money for this situation that is not in the general fund that pays salaries. We must take advantage of the \$300,000; if we do not take advantage of the \$300,000 it will go away.

Alderman Elmore

Alderman Elmore with due respect to the Parks and Recreation Board he is not in good conscience ready for us to install a splashpad regardless of partial funding from the State of Illinois. Reasons are as follows:

The Body that states they will refund us up to \$300,000, he has seen projects for municipal improvements canceled when it comes time to write the check. The State of Illinois is in such flux any promise from them is concerning. The \$300,000 does not complete this project.

There will be money coming out of the Parks and Recreation savings that can only be used for Parks and Recreation.

We have outdated playground equipment, we have parks with overgrown vegetation, some lack picnic tables, benches, restrooms. The reason for some of that is years of abuse and lack of monitoring.

How does a splashpad have use control? Free of charge for anyone to come in and use shooting clean chemical water. Our grass cutting expenses are higher because we are understaffed. He is not referencing COVID-19 furloughs and layoffs he is speaking of the hiring freeze that Council implemented years prior to COVID situation. There will be an additional unfunded expense and

those funds do come out of the budget. He worked on the dog park and Tour de Belleville and his personal first rule of thumb was it would not cost the City any money.

Tonight's recommendation from our esteemed Parks Board is to seek a bid from a qualified contractor. This recommendation does not cost anything. The Parks Board is doing their job flawlessly. They want to add a feature to one of our parks...a feature he would love. He asks the Board to look at other things i.e. improvements, updating the current parks.

We need to look for features that will protect our City finances. We must not follow up furloughs and layoffs with a splashpad to be used nine (9) or ten (10) weeks a year. He is truly sorry to rain on anyone's parade, but this is a mistake.

Alderman Wigginton

Alderman Wigginton stated this will make people happy or mad. He was not opposed when the Belleville swimming pool closed. From a business point of view this is not a good idea, this is a short usage feature, liability for insurance, maintenance. The grant is wonderful; however, he is concerned where this will go down the road.

Alderwoman Stiehl

Alderwoman Stiehl stated she is concerned from an insurance standpoint. This will not be monitored 24/7.

Alderman Randle

Alderman Randle stated his concerns are the ongoing costs of the project itself. What has the City determined for the cost of the project and more importantly where the money comes from. Do we have any information from Alton, Illinois regarding costs associated with their pad?

Director of Public Works, Jason Poole advised Alton is still under construction. It is hard to come up with costs until the design is completed. What you are voting on tonight is entering into a contract to come up with a design. The grant is for \$300,000...we can do a \$300,000 splashpad or add money to it. Mayor Eckert stated there is money in the recreation budget for projects like this. There has been criticism because the City closed the 37-year-old swimming pool. The splashpad will offer a summertime for parents and children.

Alderman Wigginton

If the Council votes no tonight will the motion go dead, and the City loses the grant; Mayor Eckert advised this is correct. If the council votes does the City automatically get the money and what if down the road it's decided it doesn't work; Mayor Eckert state the City will be responsible for the design build portion and will have to return the money if it's not built.

Alderman Kinsella

Alderman Kinsella advised some are concerned about insurance. This is no different than when we had a swimming pool. There will be a fence around it. There will be set hours. He hears no complaints from constituents about tables missing in parks, he does hear a town like Belleville should have a swimming pool or at least a splashpad. This is coming from seniors that would like it for their grandchildren.

Alderman Elmore

Alderman Elmore stated he receives a lot of complaint for a lack of picnic tables; however, he also has received reasons why we don't have enough picnic tables. A splashpad is a fabulous idea if you have a swimming pool.

Alderman Weygandt

Alderman Weygandt asked the cost of the design; Director of Public Works, Jason Poole, stated it will be incorporated in the bid. Alderman Weygandt asked if this is for residents only; Director of Public Works, Jason Poole, stated it will be open to the public. Alderman Weygandt requested to get the designed finished first and vote at a later date.

Alderman Ferguson

Pursuant to Section 31.128 of the Revised Code of Ordinances, I write to provide a quarterly report on pending legal matters.

- A. Ordinance Violation Cases.** The City currently has approximately 203 ordinance violation cases pending.

C. **Other Civil Cases.** The City currently has pending the following other civil cases in which I am representing the City:

1. *City of Belleville v. JRG Holdings - Belleville, L.L.C.* On November 14, 2018, the City filed a Complaint for Declaratory Judgment concerning Defendant's Property at 104 North High, Belleville, Illinois (Brede Towers Apartments). Specifically, the City is seeking:
 - a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendant has willfully allowed the Property to become injurious to the health and dangerous to the lives of the occupants thereof and of the public in violation of Section 92.02 of the City's Revised Code of Ordinances, as well as permitting the existence of a dangerous building in the City and further permitting same to be occupied while it is or remains in a dangerous condition in violation of Section 93.041 of the City's Revised Code of Ordinances, thereby empowering Plaintiff to immediately revoke all current occupancy permits on the Property pursuant to Section 154.22 of the City's Revised Code of Ordinances and cause the immediate vacation of the residents of such Property;
 - a permanent injunction requiring Defendants to immediately put the Property in good safe and sanitary condition in compliance with applicable codes and ordinances relating to sanitation, health, and housing, including but not limited to correcting the aforementioned violations/deficiencies related to the City electrical, mechanical, plumbing and fires safety codes, at Defendant's sole cost and expense.

2. *City of Belleville v. Manhar Bhakta.* On October 16, 2020, the City filed a Complaint for Declaratory Judgment concerning Defendant's Property at 1234 Centreville Avenue, Belleville, Illinois (former Executive Inn). Specifically, the City is seeking:
 - a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendant has willfully allowed the

Property to become injurious to the health and dangerous to the lives of the occupants thereof and of the public in violation of Section 92.02 of the City's Revised Code of Ordinances;

- permanent injunction requiring Defendants to immediately put the Property in good safe and sanitary condition in compliance with applicable codes and ordinances relating to sanitation, health, and housing, including but not limited to correcting the violations/deficiencies on the Property noted in the reports attached hereto as Exhibit A in compliance with the City's Revised Code of Ordinances, at Defendant's sole cost and expense.

3. *City of Belleville v. Bobby Winters and Renee Rice.* On October 19, 2020, the City filed a Complaint for Declaratory Judgment concerning Defendant's Property at 830 Centreville Avenue, Belleville, Illinois (former Executive Inn). Specifically, the City is seeking:

- a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendants' collection and storage of tree limbs, branches, trunks and stumps on the Property from at least September 13, 2019 to present constitutes a prohibited nuisance under Chapter 93 of the City's Revised Code of Ordinances;
- a permanent injunction requiring Defendants to immediately remove the tree limbs, branches, trunks, stumps and other debris on the Property from at least September 13, 2019 to present as abatement of the prohibited nuisance under Chapter 93 of the City's Revised Code of Ordinances, at Defendants' sole cost and expense;
- assess a daily fine against Defendants under Section 93.999 of the City's Revised Code of Ordinances from at least September 13, 2019 to present for Defendants' ongoing violation of Chapter 93 of the City's Revised Code of Ordinances;
- a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendants' operation of Monkey Tree Service on the Property from at least September 13, 2019 to present without a business occupancy permit violates of Section 110.25 of the City's Revised Code of Ordinances;
- a permanent injunction requiring Defendants to immediately cease the operation of Monkey Tree Service on the Property in violation of Chapter 110 of the City's Revised Code of Ordinances;
- assess a daily fine against Defendants under Section 110.999 of the City's Revised Code of Ordinances from at least September 13, 2019 to present

for Defendants' ongoing violation of Chapter 110 of the City's Revised Code of Ordinances;

- a binding declaration of the rights of the parties to this case, including but not limited to a declaration that Defendants have Defendants operation of Monkey Tree Service on the Property is a non-permitted use in violation of Section 162.093 of the City's Revised Code of Ordinances;
 - a permanent injunction requiring Defendants to immediately cease the operation of Monkey Tree Service on the Property in violation of Chapter 162 of the City's Revised Code of Ordinances;
 - assess a daily fine against Defendants under Section 162.999 of the City's Revised Code of Ordinances from at least September 13, 2019 to present for Defendants' ongoing violation of Chapter 162 of the City's Revised Code of Ordinances.
4. *Belleville Professional Firefighters, IAFF Local 53 v. City of Belleville.* On August 7, 2019, Belleville Professional Firefighters, IAFF Local 53 filed a Complaint for declaratory judgment seeking to invalidate the City's ordinance providing procedures related to the Illinois Public Safety Employee Benefits Act (Sections 33.101 through 33.106 of the City's Revised Code of Ordinances. On City's behalf, I filed a Motion to Dismiss which the Court partially granted and partially denied. Therefore, the matter remains pending.
5. *Michael Hagberg v. City of Belleville.* On January 30, 2020, Plaintiff filed a so-called "Motion for Writ of Mandamus", purportedly seeking *mandamus* relief concerning various expenditures from tax increment financing districts within the City of Belleville over several years. On City's behalf, I filed a Motion to Dismiss which remains pending.

There are other lawsuits being handled through the City's insurance company.

- D. Other Miscellaneous Cases.** In addition to the above cases, there are a number of cases where the City is named as a Defendant in mortgage foreclosure lawsuits. The City is named as a Defendant because of municipal liens. These liens are typically extinguished in the foreclosure action. It is doubtful if the City will collect any of the amounts liened from these cases. There are also a number of cases where the City has filed proof of claims in Bankruptcy Court. These proof of claims are normally for sewer or trash charges and, in most cases, the City is unable to collect on any of these.

Council Members:

Following up from the previous Council meeting on 10/19/2020, the Parks and Recreation Department, as recommended by the Parks and Recreation Board, would like to enter into a contract with Water Odyssey to provide design and build services for a municipal splashpad. As stated previously, the City received a DCEO grant for \$300,000 for this project with any additional money coming from the Recreation Fund which can only be used for recreation related items and services. If we do not complete the project, we lose the grant money.

As requested, here are some further details discovered since the last meeting. If we proceed with the design and do not proceed with the build of the project, the City does not pay for anything. In other words, the design services are free of charge. As for the maintenance of it, they told me to schedule approximately 2 hours per week. Obviously, the winterization and summerization are more detailed and will take more time. An additional person will not be needed to maintain the facility. Maintenance will occur as it is done in the rest of the park. The largest cost is the water used. Utilizing a flow through design of a project of this caliber, we would conservatively estimate a cost of \$19-20K per season. This expense will be covered by the Recreation Fund, not the General Fund.

For some of you questioning what exactly a splashpad is, the simplest way is to think of it as a playground only with running water. I have attached a few designs for your review to give you an idea of some possibilities.

Also, of note, Swansea, Millstadt, O'Fallon, and many St. Louis communities have splashpads in our area. The Parks Dept and the Parks Board believe this would be a great addition to the City of Belleville, and we are hopeful to be able to proceed with design services.

**RESOLUTION EXTENDING LOCAL MEASURES RELATED
TO THE RESTORE ILLINOIS GUIDELINES/MITIGATION PLAN
FOR SAFE BUSINESS OPERATIONS DURING THE COVID-19 PANDEMIC**

THE CITY OF BELLEVILLE, ST. CLAIR COUNTY, ILLINOIS (THE "CITY"), IS A DULY ORGANIZED AND EXISTING MUNICIPALITY CREATED UNDER THE PROVISIONS OF THE LAWS OF THE STATE OF ILLINOIS.

THE CITY OF BELLEVILLE IS NOW OPERATING UNDER THE PROVISIONS OF THE ILLINOIS MUNICIPAL CODE, AS SUPPLEMENTED AND AMENDED AND AS A HOME RULE MUNICIPALITY PURSUANT TO ARTICLE VII OF THE ILLINOIS CONSTITUTION OF 1970; AND IN THE EXERCISE OF ITS HOME RULE POWERS.

WHEREAS, on May 5, 2020, Illinois Governor JB Pritzker released *Restore Illinois* Guidelines, a five-phased plan that reopened our State within five regions, guided by health metrics and with marked by distinct business, education, and recreation activities characterizing each phase, and recognizing that the economy will start growing again when consumers feel that it is safe to return to work, shop and dine out, and engage in social and recreational activities, during the COVID-19 Pandemic;

WHEREAS, the Southern Region in the *Restore Illinois* Guidelines, which includes the City, advanced to Phase 3 in the *Restore Illinois* Guidelines on May 29, 2020, and further advanced to Phase 4 of the *Restore Illinois* Guidelines on June 26, 2020;

WHEREAS, the State of Illinois has previously released industry-specific guidelines that allow for the safe reopening of certain businesses under Phase 3 and Phase 4 in the *Restore Illinois* Guidelines (ie. retail, offices, manufacturing, barbershops and salons, summer programs, various outdoor recreation activities and bars and restaurants for outdoor dining) and business toolkits complete with signage, training checklists, and other resources to ensure business and activities are conducted in accordance with appropriate public health recommendations (see <https://dceocovid19resources.com/restore-illinois>);

WHEREAS, the State of Illinois also has previously issued a Mitigation Plan in order to combat a resurgence of COVID-19, instituting 11 regions within the State, with the City as part of region 4, and providing that a region will automatically move through a three-tiered approach of additional mitigation steps to be reinstated in a region following a sustained rise in the positivity rate along with either a sustained increase in COVID-19 hospital admissions or a critical reduction in hospital bed capacity (see <https://coronavirus.illinois.gov/s/restore-illinois-mitigation-plan>);

WHEREAS, this City Council now desires to implement local measures related to the *Restore Illinois* Guidelines/Mitigation Plan that assist business operations of businesses within the City during the COVID-19 Pandemic;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BELLEVILLE, ILLINOIS as follows:

Section 1. The foregoing Recitals are hereby adopted and incorporated herein by this reference.

Section 2. As imposed by the State of Illinois, the *Restore Illinois* Phase 3 and/or Phase 4 guidelines, as well as any additional mitigation steps under the Mitigation Plan, for safe business operations during the COVID-19 Pandemic issued by the State of Illinois shall apply to the safe operations of businesses thereunder (ie. retail, offices, manufacturing, barbershops and salons, summer programs, various outdoor recreation activities and bars and restaurants for outdoor dining) as industry-specified therein.

Section 3. In addition to the aforementioned *Restore Illinois* guidelines and/or additional mitigation steps for safe business operations during the COVID-19 Pandemic, this City Council implements the following local measures that assist such safe operations of restaurants/bars, effective through and including January 5, 2021;

- A. Portions of South High Street, South Jackson Street and North Church Street shall be closed at East Main Street as specified in the Outdoor Dining Concept Plan attached hereto as Exhibit A;
- B. Upon approval of a Temporary Outdoor Dining Permit Application attached hereto as Exhibit B by the City Zoning Administrator and the Mayor as Local Liquor Commissioner, if applicable, a restaurant/bar in City may expand outdoor seating for patrons onto City sidewalks/property, closed streets and/or private property subject to the requirements set forth in the aforementioned *Restore Illinois* Guidelines/Mitigation Plan and the Temporary Outdoor Dining Permit Requirements attached hereto as Exhibit C.

Section 4. This Resolution shall be in full force and effect upon its passage and approval as provided by law, and shall supersede City Council Resolution No. 3389.

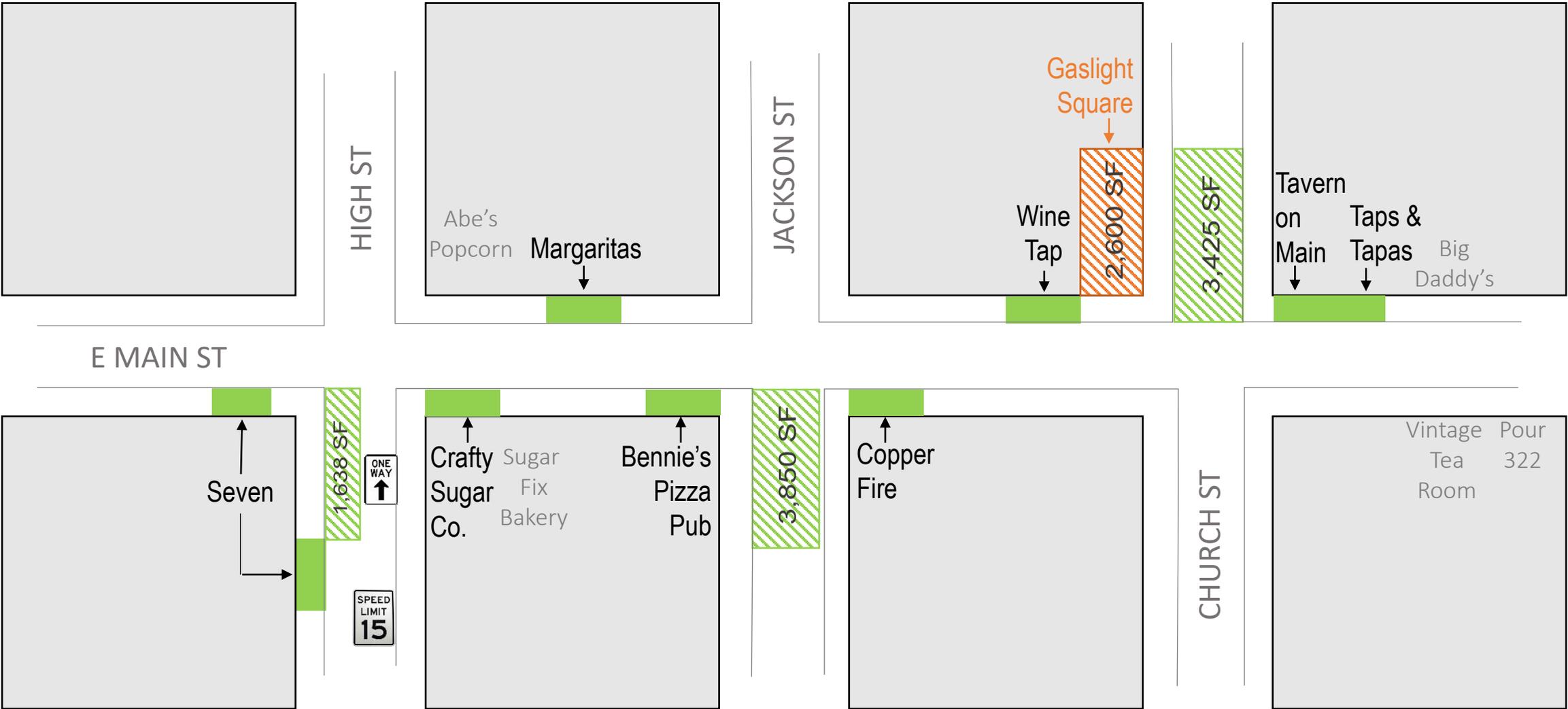

Temporary Outdoor Dining Permit Requirements

GENERAL INFORMATION

A Temporary Outdoor Dining Permit is required. There is no fee for this permit. An exhibit (drawing) showing the proposed layout of the outdoor seating must be attached.

- Temporary Outdoor Dining Permits are valid until August 30, 2020 subject to extension or revocation dependent on the pandemic conditions.
- A certificate of dram shop/liability insurance must be submitted with the Temporary Outdoor Dining Permit application.
- All restaurants must adhere to the recommendations and requirements of the Illinois Governor's Office, Illinois Department of Public Health, and the CDC, and the St. Clair County Department of Health
- No video gaming will be permitted.
- All outdoor dining must be ADA accessible.
- The City will not provide seating for use as our inventory does not meet criteria for social distancing as defined by IDPH and the CDC.
- Appropriate lighting of the space is required if operating outside of daytime hours.
- Table spacing, seating, and cleaning will follow all state and county regulations pertaining to health and safety standards for the prevention of the spread of COVID-19.
- Outdoor dining areas must be kept clear of dishes, cups, glasses, litter, food scraps, or any other waste. Said areas must be continuously supervised by employees of the establishment during business hours.
- Live music is permitted, but employees and performers should follow social distancing guidelines, keeping the maximum distance possible from each other and from customers. Performers should wear face coverings where possible and the use of barriers between singers, customers and employees during the performance is strongly encouraged.
- For dining areas located on a sidewalk, the area must be designated with a railing or barrier to define the area clearly and safely for pedestrians. A minimum of forty-eight (48) inches width of unobstructed sidewalk reserved for pedestrian use between the outdoor dining area and the street curb is required.
- Employees providing service must wear mask.

EXHIBIT "C"

GENERAL REQUIREMENTS (CONT.)

- Access to fire hydrants, fire hose connections for sprinkler systems, and entrances and exits of all buildings shall not be obstructed at any time by barriers or seating.
- Access to the interior restrooms must be provided with separate entrance and exit to said facilities.
- The expanded outdoor dining areas approved via the City's Special Event Permit must be closed no later than 10:00 pm. Any existing outdoor patio areas approved previously may stay open in accordance with the establishments existing liquor license.
- These general requirements do not supersede the State of Illinois or St. Clair County regulations. Please familiarize yourself with the state's provisions for safely reopening restaurant facilities and abide by the latest executive orders that apply to restaurants and dining services.
- The City of Belleville reserves the right to amend these requirements as needed. Any violation of the policy could result in revocation of the establishment's authority to expand the outdoor dining area and/or liquor license.

DOWNTOWN SERVICE AREA

Street Closures in the Downtown Service Area shall be as defined in the attached Exhibit "Outdoor Dining Concept Plan."

USE OF TENTS OR OTHER SHADE STRUCTURES

- All tents must be secured (weighted) properly.
- All tents must be installed per manufacture's requirements for installation/severe weather and inspected by the City of Belleville. To schedule an inspection, please call the Fire Department at 618-234-2236.
- Smoking is prohibited under tents and shade structures.
- Tents/shade structure must be open on all sides or have a retractable roof. Seating will be permitted in the portions of businesses where existing garage doors or retractable roofs are present.

ALCOHOLIC BEVERAGES

- Restaurants possessing a valid liquor license for on-site consumption shall be allowed to serve alcoholic beverages in the expanded outdoor seating areas.
- Removal of alcoholic beverages from the designated outdoor seating areas (except back into the applicant's facility) is prohibited.

USE OF PARKING AREAS

- All restaurants with private parking may utilize up to 50% of the required parking for the restaurant space. If restaurant is located within a retail center, the space available to expand the use will be 50% of the required parking for the restaurant space (not the total retail center square footage).
- An approved temporary barrier such as water filled barriers, jersey barriers, other IDOT approved barriers must be in place to define the outdoor seating area.
- No handicapped accessible parking spaces may be utilized for expanded outdoor seating.

RESTAURANTS UTILIZING SIDEWALKS OR STREETS

- No cooking, food preparation or open flames are permitted in the outdoor dining area.
- Space heaters are permitted provided that they are an outdoor approved type, are located in accordance with the manufacturer's recommendations, and are located at least two (2) feet from the edge of any umbrella canvas, tents, or any other flammable object or material.
- All restaurants utilizing the public right-of-way will need Provide Certificate of Insurance listing the City of Belleville, 101 South Illinois Street, Belleville, Illinois as additional insured in the amount of \$1 million dollars per person and \$2,000,000 aggregate prior to event.

REVOCATION

The City will have the authority to revoke an approved Temporary Outdoor Dining Permit if any of the following occurs:

- The applicant has misrepresented facts or provided false information in the temporary outdoor dining permit application.
- The outdoor seating area is operated in violation of the terms or conditions of the outdoor seating permit.
- The outdoor seating area or the establishment is operated in violation of the Municipal Code, or other applicable federal, state, or local law.
- The outdoor seating area constitutes a public nuisance or a hazard to the public health, safety, or welfare of the public, or is endangering the life or property of others.

Caveat: The City may require modifications to increase safety, improve passage, prevent damage to the City's sidewalk or right-of-way, or maintain a style consistent with the surrounding area. In instances where it is found that the applicant has misrepresented facts or has not adhered to requirements, the Temporary Outdoor Dining Permit may be revoked.



TEMPORARY COVID – 19 OUTDOOR DINING PERMIT APPLICATION

To ensure that social distancing practices and requirements are being met while encouraging restaurant establishments to resume operations, the City of Belleville is providing the following outdoor dining requirements to ensure flexibility. We are providing these outdoor dining requirements where outdoor dining may not be otherwise permitted or require other procedures under the City of Belleville Municipal Code. This temporary allowance is in effect through August 30, 2020.

PERMIT PROCESS

Permit: A completed Temporary Outdoor Dining Permit application must be sent via e-mail to edpz@belleville.net. The applicant will be notified by the City of Belleville once the review has been completed or if additional information is needed.

No fee is required.

Contact: For questions regarding the permit process or requirements, contact the Economic Development and Planning Division at edpz@belleville.net or 618-233-6810, extension 1250.

Liquor Sales: For specific requirements regarding liquor sales, please contact the Mayor/Liquor Commissioner's Office meckert@belleville.net or 618-233-6518, extension 1207.

Expiration: Approved Temporary Outdoor Dining Permits expire August 30, 2020. **Subject to extension or revocation dependent on pandemic conditions.*

THE CITY OF BELLEVILLE IS NOW OPERATING UNDER THE PROVISIONS OF THE ILLINOIS MUNICIPAL CODE, AS SUPPLEMENTED AND AMENDED AND AS A HOME RULE MUNICIPALITY PURSUANT TO ARTICLE VII OF THE ILLINOIS CONSTITUTION OF 1970; AND IN THE EXERCISE OF ITS HOME RULE POWERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEVILLE, ILLINOIS:

Whereas, an application has been filed requesting a Special Use Permit to establish a convenience store, with a print shop, and food preparation for carry-out and delivery, at 9700 West Main Street (parcel #02-35.0-210-040) located in a "C-2" Heavy Commercial District. (Applicable section of the Zoning Code: 162.248, 162.515).

Whereas, a public hearing has been held before the City's Zoning Board of Appeals which has issued its advisory report.

NOW, THEREFORE, be it ordained by the City Council of the City of Belleville, Illinois as follows:

Section 1. That the application requesting a Special Use Permit to establish a convenience store, with a print shop, and food preparation for carry-out and delivery, at 9700 West Main Street (parcel #02-35.0-210-040) located in a "C-2" Heavy Commercial District is hereby granted with the following stipulation: (Applicable section of the Zoning Code: 162.248, 162.515)

1. Use limited to delivery of goods and services. There shall be no walk-up store sales.

Section 2. That conflicting ordinances or pertinent portions thereof in force at the time of this ordinance takes effect are hereby repealed.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication, all as provided by law.
