

ORDINANCE NO. 8348-2019

AN ORDINANCE AMENDING TITLE IX (GENERAL REGULATIONS),  
CHAPTER 94 (PARKS AND RECREATION), SECTION 94.01(T) OF THE  
REVISED ORDINANCES OF THE CITY OF BELLEVILLE, ILLINOIS

THE CITY OF BELLEVILLE, ST. CLAIR COUNTY, ILLINOIS (THE "CITY"), IS A DULY ORGANIZED AND EXISTING MUNICIPALITY CREATED UNDER THE PROVISIONS OF THE LAWS OF THE STATE OF ILLINOIS.

THE CITY OF BELLEVILLE IS NOW OPERATING UNDER THE PROVISIONS OF THE ILLINOIS MUNICIPAL CODE, AS SUPPLEMENTED AND AMENDED AND AS A HOME RULE MUNICIPALITY PURSUANT TO ARTICLE VII OF THE ILLINOIS CONSTITUTION OF 1970; AND IN THE EXERCISE OF ITS HOME RULE POWERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEVILLE, ILLINOIS:

**Section 1.** That Chapter 94 (Parks and Recreation), Section 94.01(T) is hereby amended by repealing said Section 94.01(T) its entirety, and substituting in lieu thereof the following:

(T) It shall be unlawful for any person knowingly to possess alcohol in Rotary, Ever and Anon, Hough, Southside [and Pleasant Hill](#) Parks unless he or she has been issued a permit by the Mayor with Council approval.

**Section 2.** That conflicting Ordinances or pertinent portions thereof in force the time this takes effect are hereby repealed.

**Section 3.** Any person violating this Ordinance shall be subject to the penalties of Article IX (General Regulations), Chapter 94 (Parks and Recreation), Section 94.99 (Penalty).

**Section 4.** This Ordinance shall be in full force and effect from and after its passage, approval and publication, in pamphlet form, all as provided by law.
